- 1. Nominations are invited on this form, not later than **Wednesday**, **18th November 2020** for the election of parent governor to the governing body **for a four-year period**.
- 2. Each candidate <u>must be a parent/carer of a registered pupil at the school</u> at the time of the election and must agree to being nominated. A parent may be supported by a proposer and a seconder or may nominate themselves.
- 3. If there is more than one nomination an election will be held. Candidates should therefore provide a statement of not more than 100 words which will be sent to parents with the ballot papers.
